Users can take advantage of many standard SAP functions that are only made available with a non-jurisdiction based configuration.


INTEGRATION ARCHITECTURE

Global Next embraces SAP technology, such as the SAP Internet Communication
Framework (ICF) to communicate with Determination via SOAP. No additional
middleware, hardware, or software is required, minimizing implementation and maintenance cost, and
reducing risk of failure. The entire tax interface is writing in ABAP using object oriented coding, all objects are in
a designated ONESOURCE Indirect Tax SAP name space, ensuring supportability and ease of installation. The
solution is delivered via a set of transport objects with preconfigured settings as well as custom tables to meet
each customers unique taxing needs. Ongoing support and maintenance releases are shipped as transport
objects to SAP customers, which are easily installable and can migrate as part of our SAP system footprint.

GOODS MOVEMENT

This is a standalone ABAP solution to manage tax liabilities resulting from the post-purchase movement of goods. Goods Movement can be configured to identify specific Goods Movement transactions for tax calculation, then post GL entries in SAP to accrue the estimated tax, and display the results in a custom SAP report. Goods Movement is a current U.S. tax solution add-on.
